Based on your commitment, you may get separate emails for each session you have agreed to judge. Please note that, in case you get multiple emails, they are for separate sessions and not duplicates.

There are 2 judges for every hour in each STATION.

Each STATION in every SESSION will have 12 presentations. Of the total of **5 minutes**, the **presenter will have 3 minutes**, and **2 minutes will be for discussions and Question**.

SCORING SHEET

1. Judges have to select best Poster from their respective station during their online session.
2. Scoring Sheet will be provided online on www.masicongondia2026@gmail.com ,under the heading of ABSTRACT. Judges are requested to download the same from site.
3. Score to be Submitted via mail to abstractmasicon26@gmail.com
4. NOTE- Only select One candidate from your station.

GENERAL INSTRUCTIONS

1. The link to join the zoom platform as a Judge will be available at the Website from 18th January 2026 onwards but will be active only from 20th January 2026 morning
2. Judges should click on the link as per your schedule using a LAPTOP **with a good and stable Wi-Fi internet connection**.
3. Please Login through your **Judge's link only**, at least 10 minutes before the start of your session.
4. Judges should **Login with the same name given for registration** or rename yourselves after login. Logging in with a different name will not recognize your identity and hence may not be able to assess the presentation assigned to you.
5. Judges are requested to sit in a well-lit room facing a good light source,
6. Avoid any bright light behind you.
7. For uninterrupted transmission please **switch off other gadgets** which can consume your internet bandwidth.
8. Ensure that you are in a room without any external disturbances and distractions.
9. Prior to viewing the presentation, ensure that your **video and audio are in perfect condition**.
10. When you click on the link, no password is needed but you will be in a waiting room till the Admin allows you to enter the meeting.
11. Ideally when the presentation is going on or you fellow Judges are talking, your **Camera and Microphone** should be kept switched **OFF**.
12. Once the presentation is over, the 1st Judge asks the presenter questions regarding the topic presented, then the 2nd Judge and after that the next can make their comments or ask questions to the presenter.
13. Each Judge will have 1 minute to ask questions to the presenter.
14. Once all questions are over, the Judges are requested to note their marks in the scoring sheet in the blank spaces provided against the topics just presented.
15. Now you can be ready for the next presenter.
16. Once all 12 topics under a session are complete, the Judges are requested to **leave**

the session by logging out.
